#### **Course Description**

This course provides a general introduction to the field of developmental psychology, primarily focusing on prenatal development to early adolescence. Topics will include developmental methodology and theory relevant to biological, cognitive, emotional, and social development.

#### **Course Format**

This is an in-person class held on campus. One learning strategy employed in this class will be "flipped learning" in which students will access recorded lectures outside of class-time and then meet regularly with the instructor in person to discuss, learn in a hands-on way or apply the knowledge together as a group. **Students are expected to attend class.**

All D2L quizzes will be scheduled for class time at 12:00pm. Students will need a device connected to the internet to complete the quiz. Students may complete the quiz in the course classroom (MFH 164) or elsewhere of their choosing. For students registered with the Student Accessibility Centre, they are responsible for finding an appropriate place to write their quizzes that meets their accommodations. Students who do not have access to a device during class time should contact the instructor in advance of the quizzes.

The in-class quizzes will contain 15 multiple questions and are designed to take 15 minutes. However, all students (including students registered with the Student Accessibility Centre) will be given an accommodated time of 50 minutes (350% accommodated time). Students who accessibility accommodations require more than 3.5x accommodated time should contact the instructor.

The Final Exam is an in-person final exam that will be scheduled by the registrar's office. More details will be posted about this during the semester.

Quizzes and the final exam in this course are closed book. The use of resources, including class notes, the textbook, online resources, and calculators is prohibited during the exams in this course. Students may not communicate with others about course material or the exam either in person or electronically during exams.

#### **Course Assignment**

Students will complete one long, semester project that will contain 3 parts. The overall assignment will be to select any topic in developmental psychology controversy and compare how non-scientific sources address controversial developmental topics. Example of topics could be:

- Co-sleeping vs Cry-it-out methods
- Breastfeeding vs Formula
- Screen time
- Whole language vs Phonics
- Free Range vs Structured Play
- Time-outs, Spanking, & Discipline
- Finish Your Plate Parenting

#### - Gender Norms in Parenting

**Assignment 1** For Assignment 1, students will submit a reference list of at least 5 sources that they will use for their course project. These will include at least one academic, peer-reviewed research article about the topic, plus 4 non-scientific sources about the same topic (could be online magazine articles, blogs, youtube videos, etc.). Two of the non-scientific articles will need to do a poor job addressing the topic, and 2 do a better or fair job. This will be a one-page assignment in which sources will be listed in bibliographic, APA style. This will be submitted via D2L and worth 5% of the final course grade.

**Assignment 2** For Assignment 2, students will write a brief, 2-page analysis that highlights the findings from their 5 sources. This will be submitted via D2L. This analysis will include a summary of what scientific evidence says about their chosen topic area, along with highlights from the non-scientific sources and a comparison of how the sources' advice matches up. This will be written in APA style and worth 10% of the final course grade.

**Assignment 3** Students will use the key information from Assignment 2 to design an Infographic depicting their chosen Developmental Controversy. This will be a digital poster, PowerPoint slide, or static image file that is submitted via D2L. The infographic will balance color, format, and design with depth, breadth, and accuracy in their chosen topic. The purpose of this infographic will be to explain to non-scientific audiences reliable, evidence based information on their chosen topic.

# **Department of Psychology Criteria for Letter Grades**

Psychology course instructors use the following criteria when assigning letter grades:

A+ grade: Exceptional Performance. An A+ grade indicates near perfect performance on multiple choice and short answer exams. For research papers/essays/course projects/presentations, an A+ grade is awarded for exceptional work deserving of special recognition and is therefore not a common grade.

A, A- Range: Excellent Performance. Superior understanding of course material. Written work is very strong in terms of critical and original thinking, content, organization, and the expression of ideas, and demonstrates student's thorough knowledge of subject matter.

B Range: *Good Performance*. Above average understanding of course material. Written work shows evidence of critical thinking and attention to organization and editing but could be improved in form and/or content.

C Range: Satisfactory Performance. Adequate understanding of course material. Knowledge of basic concepts and terminology is demonstrated. Written work is satisfactory and meets essential requirements but could be improved significantly in form and content. Note: All prerequisites for courses offered by the Faculty of Arts must be met with a minimum grade of C-.

D range: *Marginally meets standards*. Minimal understanding of subject matter. Written work is marginally acceptable and meets basic requirements but requires substantial improvements in form and content. Student has not mastered course material at a level sufficient for advancement into more senior courses in the same or related subjects.

F grade: Course standards not met. Inadequate understanding of subject matter. Written work does not meet basic requirements. Student has not demonstrated knowledge of course material at a level sufficient for course credit.

It is at the instructor's discretion to round off either upward or downward to determine a final grade when the average of term work and final examinations is between two letter grades.

# **Supporting Documentation**

Students may be asked to provide supporting documentation for an exemption/special request. This may include, but is not limited to, a prolonged absence from a course where participation is required, a missed course assessment, a deferred examination, or an appeal. Students are encouraged to submit documentation that will support their situation. Supporting documentation may be dependent on the reason noted in their personal statement/explanation provided to explain their situation. This could be medical certificate/documentation, references, police reports, invitation letter, or a statutory declaration, etc. The decision to provide supporting documentation that best suits the situation is at the discretion of the student. Students cannot be required to provide specific supporting documentation, such as a medical note.

Students can make a Statutory Declaration as their supporting documentation (available at <u>ucalgary.ca/registrar</u>). This requires students to make a declaration in the presence of a Commissioner for Oaths. It demonstrates the importance of honest and accurate information provided and is a legally binding declaration. Several registered Commissioners for Oaths are available to students at no charge, on campus, please see <u>ucalgary.ca/registrar</u>.

Falsification of any supporting documentation will be taken very seriously and may result in disciplinary action through the Academic Discipline regulations or the Student Non-Academic Misconduct policy.

#### Absence From A Test/Exam

Makeup tests/exams are **NOT** an option without the approval of the instructor. Students who miss a test/exam have up to 48 hours to contact the instructor to ask for a makeup test/exam. It's the instructor's discretion if they will allow a make-up exam. Students who do not schedule a makeup test/exam with the instructor within this 48-hour period forfeit the right to a makeup test/exam. At the instructor's discretion, a makeup test/exam may differ significantly (in form and/or content) from a regularly scheduled test/exam. Once approved by the instructor a makeup test/exam must be written within 2 weeks of the missed test/exam on a day/time scheduled by the instructor.
