Course Description

This course will focus on applying concepts in developmental psychology research, such as measurement design, data collection techniques, ethical considerations, statistical approaches, and reports and presentations.

There is no written test or exam for this course. The main source of evaluation will be the research

project. You will be graded on this project in four instances: the research proposal, the first oral presentation, the second oral presentation, and the final paper. These four tasks will contribute towards **60%** of your final grade for this semester.

These research projects will be designed in small groups (3-5), presented as a group, but written individually. In the first few weeks, you will work in groups to design a research question, a hypothesis, and a basic methodology. You will present your hypotheses and research questions on **on February 1**st & **3**rd **as a group**. This will be a 5 minute presentation. More information on the presentations will be posted to D2L. you will work on your own to write the research proposal which is due **March 1**st **via D2L**. This research proposal should be 5 pages in length (excluding title page, references, and any appendices), double spaced with size 12 font and 1 inch margins.

On **April 7**th **and April 12**th, you will present your research findings as a group. This will be a 5 minute presentation. More information on the presentations will be posted to D2L. You will write a final research report due **April 12**th **via D2L.** The final report will be 8-10 page final research report (excluding title page, references, and any appendices). The report should be double spaced with size 12 font and 1 inch margins. This report will contain all the elements of a research article.

Assignments

There will be 10 small lab assignments which are each worth 4% of your final grade. Each of these assignments will be associated with an in-class activity that you will complete during class.

Department of Psychology Criteria for Letter Grades

Psychology course instructors use the following criteria when assigning letter grades:

A+ grade: Exceptional Performance. An A+ grade indicates near perfect performance on multiple choice and short answer exams. For research papers/essays/course projects/presentations, an A+ grade is awarded for exceptional work deserving of special recognition and is therefore not a common grade.

A, A- Range: Excellent Performance. Superior understanding of course material. Written work is very strong in terms of critical and original thinking, content, organization, and the expression of ideas, and demonstrates student's thorough knowledge of subject matter.

B Range: *Good Performance*. Above average understanding of course material. Written work shows evidence of critical thinking and attention to organization and editing but could be improved in form and/or content.

C Range: Satisfactory Performance. Adequate understanding of course material. Knowledge of basic concepts and terminology is demonstrated. Written work is satisfactory and meets essential requirements but could be improved significantly in form and content. Note: All prerequisites for courses offered by the Faculty of Arts must be met with a minimum grade of C-.

D range: *Marginally meets standards*. Minimal understanding of subject matter. Written work is marginally acceptable and meets basic requirements but requires substantial improvements in form and content. Student has not mastered course material at a level sufficient for advancement into more senior courses in the same or related subjects.

F grade: *Course standards not met*. Inadequate understanding of subject matter. Written work does not meet basic requirements. Student has not demonstrated knowledge of course material at a level sufficient for course credit.

Supporting Documentation

Students may be asked to provide supporting documentation for an exemption/special request. This may include, but is not limited to, a prolonged absence from a course where participation is required, a missed course assessment, a deferred examination, or an appeal. Students are encouraged to submit documentation that will support their situation. Supporting documentation may be dependent on the reason noted in their personal statement/explanation provided to explain their situation. This could be medical certificate/documentation, references, police reports, invitation letter, or a statutory declaration, etc. The decision to provide supporting documentation that best suits the situation is at the discretion of the student. Students cannot be required to provide specific supporting documentation, such as a medical note.

Students can make a Statutory Declaration as their supporting documentation (available at <u>ucalgary.ca/registrar</u>). This requires students to make a declaration in the presence of a Commissioner for Oaths. It demonstrates the importance of honest and accurate information provided and is a legally binding declaration. Several registered Commissioners for Oaths are available to students at no charge, on campus, please see <u>ucalgary.ca/registrar</u>.

Falsification of any supporting documentation will be taken very seriously and may result in disciplinary action through the Academic Discipline regulations or the Student Non-Academic Misconduct policy.

Absence From A Test/Exam

Makeup tests/exams are **NOT** an option without the approval of the instructor. Students who miss a test/exam have up to 48 hours to contact the instructor to ask for a makeup test/exam. It's the instructor's discretion if they will allow a make-up exam. Students who do not schedule a makeup test/exam with the instructor within this 48-hour period forfeit the right to a makeup test/exam. At the instructor's discretion, a makeup test/exam may differ significantly (in form and/or content) from a regularly scheduled test/exam. Once approved by the instructor a makeup test/exam must be written within 2 weeks of the missed test/exam on a day/time scheduled by the instructor. If a student cannot write their final exam on the date assigned by the Registrar's Office, they need to apply for a deferred exam https://www.ucalgary.ca/registrar/exams/deferred-exams.
