## **Course Description**

This course focuses on all aspects of human behavior (i.e. emotion, cognition, physiology, bias, decisionmaking) as it relates to the law or legal system. The primary goal of the course is to introduce some of the ways that psychology and the law intersect; forensic psychologists focus on examining how people function in a legal context. You will be exposed to theory and scientific evidence as it pertains to the field, but also to inherent challenges. The course will confront the views of forensic psychology that you may have acquired through media portrayals and present the realities of the field.

#### **Assessment Methods**

Students are expected to attend class regularly and to participate in class discussions. There will be three noncumulative exams in this course, one of which is during the final exam period. The exams will most likely consist of multiple-choice and short-answer questions from the text, class discussions, and lectures/PowerPoint slides. The two midterms will occur during the class time slot (50 minutes) and the final exam will be two hours. The use of iPods, iPads, Smart watches, books or notes during tests is prohibited.

## March 16, 2020 Course Outline Updates:

Given the need to move to online teaching and assessment methods, Powerpoint lectures for remaining lectures (March 16<sup>th</sup> to April 15<sup>th</sup> will be added to D2L. Additionally, lectures will be given via Zoom on D2L; this will occur at the scheduled class time (1:00-1:50 pm M/W/F). Efforts will be made to also add recordings of the Zoom lectures to the "Content" section on D2L.

The remaining Thought Paper #3 will stay the same; it is due April 8<sup>th</sup> and must be submitted via DropBox by 2 pm (existing late penalties remain in effect). You will see feedback for the thought paper posted on DropBox; your grade will be added to the grade book and posted online via D2L.

The major paper component of the course also remains the same (see description below). The paper is still due by 2 p.m. on March 30, 2020 but you no longer have to submit a hard copy; submission will be via DropBox. Paper feedback will be posted on Dropbox with your paper, and your grade will be added to the grade book and posted online via D2L.

The Final Exam will be an online exam that will be administered as Midterm #2 was. The exam is scheduled for April 23, 2020 from 3:30 to 5:30 p.m. The exam will be posted on D2L at 3:30 p.m. on April 23, 2020 and completed exams must be placed in the D2L DropBox by 5:30 p.m. Late submissions will not be accepted. Should any student face a challenge with the DropBox submission, they should contact me via email immediately to obtain assistance.

## Final Exam and Overall Course grades will be posed via D2L.

If an exam is missed, it can only be made up following the provision of appropriate documentation that is provided in the required time frame – Please follow the "Absence from a Test/Exam" rules

listed later in this course outline. Not reading the guidelines will not be accepted as a reason for failing to book makeup exams appropriately; failure to follow the makeup exam requirements will result in a grade of zero being assigned for that exam.

- <u>25% of your mark</u> will be based on a Midterm Exam #1 on Wednesday, February 5, 2020. Midterm Exam #1 will consist of material from Chapters 1, 2, 3, 4, and 6.
- <u>25% of your mark</u> will be based on a Midterm Exam #2 on Friday, March 13, 2020. Midterm Exam #12 will consist of material from Chapters 5, 7, 8, 10 and readings for Criminal Profiling.
- <u>20% of your mark</u> will be based on a Final Exam scheduled by the Registrar. The Final Exam will consist of material from Chapters 11, 13, 14, and 15.
- 4) <u>25% of your mark</u> will be based on your work in the paper component of the course. Students will write an APA-style paper of 10-12 pages in length (typed, double-spaced, 12-point font, 1" margins) which describes (1 to 1.5 pages), and then discusses (9 to 10 pages) an area of Forensic Psychology of the student's choice (i.e. deception, profiling, jury selection) and the related controversies (i.e. clinical utility; issues with accuracy and bias; sampling errors in related research; base rate issues). The paper should conclude with a 1 to 2-page conclusion of possible "next steps" in the area. Do not simply state an area of controversy; you must explain why the controversy exists and refer to relevant research findings.
- 5) APA formatting will be included as part of the evaluation of your paper. Details and a sample APA-style paper are provided here: <u>https://owl.english.purdue.edu/owl/resource/560/18/</u>
- 6) More specific details regarding grading and expectations will be discussed in class on January 13, 2020 and posted on D2L under "Communications". The paper should be submitted to the relevant dropbox on D2L by the end of class on Monday, March 30, 2020 at the latest. You will also need to hand in a paper copy of your assignment. Late assignments will be accepted with a 5% deduction penalty per day, including weekends. Without approved documentation (approval of this documentation as sufficient is at the discretion of the instructor: please refer to the Statutory Declaration form on the University of Calgary website), assignments more than 7 days late (35% deduction) will no longer be accepted.
- 7) Papers will be graded according to: adequate length; comprehensive consideration of your topic; grammar; spelling and punctuation; sentence construction; ability to effectively condense information; summary. More detailed information about the paper will be provided in class and on D2L.
- 8) <u>5% of your mark</u> will be based on completion of three brief thought papers (approximately one page in length, single spaced) that occur throughout the semester (Due January 27, February 28, April 8, 2020). More detailed information about the thought papers will be provided in class and on D2L. <u>Send your thought papers to the course Dropbox on D2L by the end of class on the day that each thought paper is due)</u>. In general, students will need to write a short document (can be in point form) in response to questions that will be posted on D2L under "Communications" prior to the due date (i.e. Ways in which media portrayals of forensic psychology topics influence beliefs; Factors that bias witness recall and other aspects of the field; Factors that may contribute to offenders being seen as "untreatable"). Grade will reflect handing in of all three documents on tie, appropriate length, and thoughtful discussion of the

posted questions. *Late thought papers will be accepted with a 5% penalty per day, including weekends. Without approved documentation, thought papers more than 3 days late will not be accepted.* 

# **Department of Psychology Criteria for Letter Grades**

Psychology professors use the following criteria when assigning letter grades: A+ grade: *Exceptional Performance*. An A+ grade indicates near perfect performance on multiple choice and short answer exams. For research papers/essays/course projects/presentations, an A+ grade is awarded for exceptional work deserving of special recognition and is therefore not a common grade.

A, A- Range: *Excellent Performance*. Superior understanding of course material. Written work is very strong in terms of critical and original thinking, content, organization, and the expression of ideas, and demonstrates student's thorough knowledge of subject matter.

B Range: *Good Performance*. Above average understanding of course material. Written work shows evidence of critical thinking and attention to organization and editing but could be improved in form and/or content.

C Range: *Satisfactory Performance*. Adequate understanding of course material. Knowledge of basic concepts and terminology is demonstrated. Written work is satisfactory and meets essential requirements but could be improved significantly in form and content. Note: All prerequisites for courses offered by the Faculty of Arts must be met with a minimum grade of C-.

D range: *Marginally meets standards*. Minimal understanding of subject matter. Written work is marginally acceptable and meets basic requirements but requires substantial improvements in form and content. Student has not mastered course material at a level sufficient for advancement into more senior courses in the same or related subjects.

F grade: *Course standards not met.* Inadequate understanding of subject matter. Written work does not meet basic requirements. Student has not demonstrated knowledge of course material at a level sufficient for course credit.
