## **Course Description**

This course will provide students with an introduction to human psychopathology. The course will begin with historical, theoretical, and socio-cultural perspectives on abnormal human psychology. As the course progresses you will become familiar with current mental disorder classifications and diagnostic criteria, and ethical issues surrounding mental health. Causes and treatments of various mental disorders will also be covered. Some of the disorders discussed will include: anxiety, trauma-related, and obsessive compulsive disorders, mood disorders and suicide, and schizophrenia spectrum and other psychotic disorders. The class format consists primarily of lectures with book chapter readings. Lectures aim to supplement and compliment book chapters, not necessarily to repeat them. Therefore, some tested material will only be understood if you attend lectures. To appeal to different learning styles a textbook with a higher number of visuals and case examples was chosen. To further help listening/visual learners, case vignettes and supplementary audio/video materials will also be used during lectures. We will aim to integrate short, productive discussions within full class and/or smaller groups so that you have the chance to critically discuss concepts with your peers. By the end of the course you should have a greater understanding of the history and theories of human psychopathology, different mental disorders, their categorizations, causes, symptoms and treatments, and current issues relating to the clinical mental health field moving forward.

#### Please note:

The required text has been ordered to the University of Calgary bookstore and is available for purchase there. If you decide to purchase the text outside of the university bookstore, please ensure that you buy the 5<sup>th</sup> Canadian Edition (DSM 5 update). Many disorders have undergone changes in both diagnostic criteria and categorizations from DSM-4-TR to DSM 5. If you purchase an older version of the book you may have difficulty keeping up with course material and may have trouble during the midterms/final exam.

If you decide to purchase through the university bookstore (recommended) you have two options: 1) you can purchase the hardcover book including access to Nelson Education's MindTap digital resource (approx. \$170 + taxes). If you purchase the hardcopy of the book it is yours to keep but *your access to MindTap software will expire 1 year after you activate it.* 2) As a less expensive alternative, you can purchase access to MindTap only (no book; approx. \$80 + taxes). With this option you will also be leasing the MindTap software but *your access will expire 1 year after you activate it.* You can decide for yourself which of the two above options is suitable for you.

MindTap is a digital resource which contains a full digital copy of the required textbook, supplementary video materials, flash cards, chapter quizzes etc. The use of this resource is recommended as it may increase your ability to be successful in this course. MindTap is accessible on a web browser and has apps for iOS and Android. A representative from Nelson Education Ltd will come in and briefly demonstrate the MindTap resource at the beginning of the semester.

#### **Assessment Methods**

Evaluation will consist of two midterms (October 13<sup>th</sup> and November 15<sup>th</sup>). Each midterm is worth 30% of your final mark. The first midterm will cover materials from September 12<sup>th</sup> to October 11<sup>th</sup> (inclusive; chapters 1-7). The second Midterm will NOT be cumulative and will only cover materials from October

16<sup>th</sup> to November 13<sup>th</sup> (inclusive; chapters 8-12). The final exam will be worth 40% of your final grade and will be cumulative (all lecture material from September 11<sup>th</sup> to December 8<sup>th</sup> [inclusive] will be tested; chapters 1-16). An emphasis will be put on material after the second midterm (chapters 13-16). You have the option to participate in research studies to earn credit of up to 2% of your final grade (see below).

Both of the midterms and the final exam will be multiple choice and will consist of readings from book chapters and lecture material. The midterms will be held in our regular classroom and will be 50 minutes long. The final exam will be scheduled by the registrar's office. The time, date, and location of the final exam will be determined by the registrar. The final exam will be approximately 2.5 hours in length. No electronics (phones, computers etc.), books, notes, other aids or equipment etc. will be allowed during the midterms/final exam.

#### **Department of Psychology Criteria for Letter Grades**

Psychology professors use the following criteria when assigning letter grades:

A+ grade: Exceptional Performance. An A+ grade indicates near perfect performance on multiple choice and short answer exams. For research papers/essays/course projects/presentations, an A+ grade is awarded for exceptional work deserving of special recognition and is therefore not a common grade.

A, A- Range: Excellent Performance. Superior understanding of course material. Written work is very strong in terms of critical and original thinking, content, organization, and the expression of ideas, and demonstrates student's thorough knowledge of subject matter.

B Range: *Good Performance*. Above average understanding of course material. Written work shows evidence of critical thinking and attention to organization and editing but could be improved in form and/or content.

C Range: Satisfactory Performance. Adequate understanding of course material. Knowledge of basic concepts and terminology is demonstrated. Written work is satisfactory and meets essential requirements but could be improved significantly in form and content. Note: All prerequisites for courses offered by the Faculty of Arts must be met with a minimum grade of C-.

D range: *Marginally meets standards*. Minimal understanding of subject matter. Written work is marginally acceptable and meets basic requirements but requires substantial improvements in form and content. Student has not mastered course material at a level sufficient for advancement into more senior courses in the same or related subjects.

F grade: Course standards not met. Inadequate understanding of subject matter. Written work does not meet basic requirements. Student has not demonstrated knowledge of course material at a level sufficient for course credit.

#### **Reappraisal of Grades**

A student who feels that a piece of graded term work (e.g., term paper, essay, test) has been unfairly graded, may have the work re-graded as follows. The student shall discuss the work with the instructor within 15 days of being notified about the mark or of the item's return to the class; no reappraisal of term work is permitted after the 15 days. If not satisfied, the student shall immediately take the matter to the Head of the department offering the course, who will arrange for a reassessment of the work within the next 15 days. The reappraisal of term work may cause the grade to be raised, lowered, or to remain the same. If the student is not satisfied with the decision and wishes to appeal, the student shall address a letter of appeal to the Dean of the faculty offering the course within 15 days of the unfavourable decision. In the letter, the student must clearly and fully state the decision being appealed, the grounds for appeal, and the remedies being sought, along with any special circumstances that warrant an appeal of the reappraisal. The student should include as much written documentation as possible.

#### **Plagiarism and Other Academic Misconduct**

Intellectual honesty is the cornerstone of the development and acquisition of knowledge and requires that the contribution of others be acknowledged. Consequently, plagiarism or cheating on any assignment is regarded as an extremely serious academic offense. Students who miss a test/exam have up to 48 hours to contact the instructor and to schedule a makeup test/exam. Students who do not schedule a makeup test/exam with the instructor within this 48-hour period forfeit the right to a makeup test/exam. At the instructor's discretion, a makeup test/exam may differ significantly (in form and/or content) from a regularly scheduled test/exam. Except in extenuating circumstances (documented by an official University medical excuse), a makeup test/exam must be written within 2 weeks of the missed test/exam during exam make-up hours provided by the department <a href="http://psychology.ucalgary.ca/undergraduate/exam-and-course-information#mues">http://psychology.ucalgary.ca/undergraduate/exam-and-course-information#mues</a>. Under no circumstances will this be accommodated by the department.

Under no circumstances will this be accommodated by the department.
