Course Description and Goals

This course explores the ways in which psychological research, theories and practice are applied to questions of law. The term forensic psychology has become increasingly used to define any application of psychological knowledge or methods to a task faced by the legal system. This course will look at a number of the issues that arise that benefit from psychology including roles for psychologists, policing issues, racial vs criminal profiling, deception and eyewitness testimony, and discrimination.

Prerequisites

Psyc 312 – Experimental Design and Quantitative Methods

Required Text

There are 2 required texts, both available in the University of Calgary bookstore.

Main text: Wrightsman, L.S. and Porter, S. (2006). *Forensic Psychology:* 1st *Canadian Edition.* Thomson-Nelson.

Supplementary text: Barrett, K.H. & George, W.H. (Eds.). (2005). *Race, Culture, Psychology & Law*. Sage.

Evaluation

As this class is highly participative with case studies and class exercises, participation will be graded.

- 1. Participation (20% of final grade)
- 2. Mid-term Essay Due March 2 (30% of final grade)
- 3. Final Exam in class April 13 (50% of final grade)
- 1. **Participation:** worth 20% of grade. It will be indicated by attendance (see more on Blackboard); evident completion of readings and preparedness for each class; and active participation in class discussions, group dialogues and exercises. Participation is crucial as the lectures will often differ substantially from the material in the text. To benefit maximally from lectures, discussions, and activities in class, students are strongly advised to complete the assigned readings before class. For each class, a group of students will be charged with the task of leading a class discussion on issues from the readings. Additionally, discussion

- leaders will submit a 1 page thought paper to the professor on the day of the session. Although discussion leaders are charged with providing discussion questions and facilitating the discussion, all students are expected to read the assigned materials and come prepared to class (see Blackboard for more information).
- 2. **Mid-term Presentations:** worth 30% of grade. Essays are to be delivered electronically by email no later than 12 pm on March 2. NO late assignments will be accepted. Depending on class size, each student or a group of students will be assigned a specific topic to deliver to the class orally or in writing. More information on length, writing/presentation tips and topics will be provided in class and on Blackboard.
- 3. Final Exam: worth 50% of grade. Held in class April 13. The final exam will be in the form of a quasi 'moot' court. Each student will be asked to prepare a detailed argument on a particular topic covered in the course, or that pertains to the course, that focuses on how and why psychological theory, research and practices are critical to a given legal issue. Topics must be discussed and cleared with the professor prior to March 16. Length of arguments will be determined by class size and students will be required to submit a 3-5 page paper which clearly presents the oral argument.

Reappraisal of Grades

A student who feels that a piece of graded term work (e.g., term paper, essay, test) has been unfairly graded, may have the work re-graded as follows. The student shall discuss the work with the instructor within 15 days of being notified about the mark or of the item's return to the class. If not satisfied, the student shall immediately take the matter to the Head of the department offering the course, who will arrange for a reassessment of the work within the next 15 days. The reappraisal of term work may cause the grade to be raised, lowered, or to remain the same. If the student is not satisfied with the decision and wishes to appeal, the student shall address a letter of appeal to the Dean of the faculty offering the course within 15 days of the unfavourable decision. In the letter, the student must clearly and fully state the decision being appealed, the grounds for appeal, and the remedies being sought, along with any special circumstances that warrant an appeal of the reappraisal. The student should include as much written documentation as possible.

Plagiarism and Other Academic Misconduct

Intellectual honesty is the cornerstone of the development and acquisition of knowledge and requires that the contribution of others be acknowledged. Consequently, plagiarism or cheating on any assignment is regarded as an extremely serious academic offense. Plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Students should examine sections of the University Calendar that present a Statement of Intellectual honesty and definitions and penalties associated with Plagiarism/Cheating/Other Academic Misconduct.

Academic Accommodation

It is the student's responsibility to request academic accommodations. Absence From A Test/Exam

Makeup tests/exams are NOT an option without an official University medical excuse (see the University Calendar). A completed Physician/Counselor Statement will be required to confirm absence from a test/exam for health reasons; the student will be required to pay any cost associated with this Statement. Students who miss a test/exam have 48 hours to contact the instructor and to schedule a makeup test/exam. Students who do not schedule a makeup test/exam with the instructor within this 48-hour period forfeit the right to a makeup test/exam. At the instructor's discretion, a makeup test/exam may differ significantly (in form and/or content) from a regularly scheduled test/exam. Except in extenuating circumstances (documented by an official University medical excuse), a makeup test/exam must be written within 2 weeks of the missed test/exam.

Freedom of Information and Protection of Privacy (FOIP) Act

The FOIP legislation disallows the practice of having student's retrieve tests and assignments from a public place. Therefore, tests and assignments may be returned to students during class/lab, or during office hours, or via the Department Office (Admin 275), or will be made available only for viewing during exam review sessions scheduled by the Department. Tests and assignments will be shredded after one year. Instructors should take care to not link students' names or UCIDs with their grades or other FOIP-sensitive information.

Course Credits for Research Participation (Max 2% of final grade)

Students in most psychology courses are eligible to participate in Departmentally approved research and earn credits toward their final grades. A maximum of two credits (2%) per course, including this course, may be applied to the student's final grade. Students earn 0.5% (0.5 credits) for each full 30 minutes of participation. The demand for timeslots may exceed the supply in a given term. Thus, students are not guaranteed that there will be enough studies available to them to meet their credit requirements. Students should seek studies early in the term and should frequently check for open timeslots.
