### **Course Description and Goals**

An advanced survey of some of the fundamental issues and recent developments in theoretical psychology.

### **Required Text**

Readings will be assigned. They will either be available through the library or the course instructors.

#### **Evaluation**

The final course grade will be based on weekly journal entries (50%; 10 weeks X 5%), a final paper (30%), and a presentation based on the final paper (20%). These must be submitted in print form.

The journal entries are to be handed in at the beginning of class. They must elaborate or discuss some point from the week's readings. Maximum word count is 500.

The presentation should be approximately 30 minutes in length and will be given the week of April 14.

The final paper is due April 25.

# **Reappraisal of Grades**

A student who feels that a piece of graded term work (term paper, essay, test, etc.) has been unfairly graded, may have the work re-graded as follows. The student shall discuss the work with the instructor within fifteen days of being notified about the mark or of the item's return to the class. If not satisfied, the student shall immediately take the matter to the Head of the department offering the course, who will arrange for a reassessment of the work within the

next fifteen days. The reappraisal of term work may cause the grade to be raised, lowered, or to remain the same.

If the student is not satisfied with the decision and wishes to appeal, the student shall address a letter of appeal to the Dean of the faculty offering the course within fifteen days of the unfavourable decision. In the letter, the student must clearly and fully state the decision being appealed, the grounds for appeal, and the remedies being sought, along with any special circumstances that warrant an appeal of the reappraisal. The student should include as much written documentation as possible.

### Plagiarism and Other Academic Misconduct

Intellectual honesty is the cornerstone of the development and acquisition of knowledge and requires that the contribution of others be acknowledged. Consequently, plagiarism or cheating on any assignment is regarded as an extremely serious academic offense. Plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not.
