Course Description

The pre-doctoral internship is a full calendar year (or two years, half- time) supervised training experience in an approved clinical setting. The internship will include intensive exposure to various professional issues, the opportunity to work with a diverse range of clinical populations and problems, and advanced training in the use of specific psychological assessment and intervention strategies.

Prerequisites

Admission to the Clinical Psychology graduate program.

Required Text

No text required. Any recommended or required readings specific to each pre-doctoral internship and specific training rotation will be communicated to interns by internship staff, such as the training director or clinical supervisors.

Assessment Methods

This internship will be evaluated on a Credit/Fail basis, based upon the recommendation of the internship staff. In order to facilitate discussion, or to deal with performance that may lead to a recommended failure, an interim evaluation of the student is expected. The internship is a pre-doctoral requirement which must be satisfactorily completed before a student will be authorized to receive a doctoral degree.
